Divorce Order and Maintenance Agreements

Do divorce orders or maintenance agreements change/or affect the liability of parties for payment of school fees?

The answer is no! Payment of school fees in Public Schools is regulated in terms of the *South African Schools Act 84 of 1996.*

We refer to the case between **Meeding** v **Hoër Tegniese Skool Sasolburg** 2012 ZAFSHC 137. MB v NB 2010 (3) SA 220 which was heard in the Bloemfontein High Court.

The case deals with divorce agreements and the payment of school fees. The court asked the question as to whether the divorce agreement changes the position of the South African Schools Act, where both parents are liable to pay school fees.

The Judge ruled that the divorce agreement does not apply to anybody that is not a party to the divorce agreement, and further that the divorce agreement does not change the position of the South African Schools Act, as parents are still jointly liable to pay school fees.

In OLD MUTUAL LIFE ASSURANCE CO (SA) LTD AND ANOTHER v SWEMMER 2004 (5) SA 373 (SCA), it was confirmed that divorce and maintenance orders are not binding on third parties, but only between the parties or parents, unless such third party have been cited in the legal proceedings.
