WAT IS NUUT RONDOM DIE BELA WETSONTWERP?

Nuutste wysiging aan die Wysigingswetsontwerp op Basiese Onderwyswette (BELA).

Die Nasionale Raad van Provinse (NRVP) het die gewysigde Wysigingswetsontwerp op Basiese Onderwyswette goedgekeur en aanvaar, met agt van die nege provinsies wat ten gunste van die veranderinge gestem het. Die goedgekeurde wetsontwerp, die gewysigde D-wetsontwerp, is deur alle provinsies behalwe die Wes-Kaap aanvaar.

Sommige van die groot veranderinge wat na skole in die D-Bill kom, sluit in:

- Om skole toe te laat om hul eie taal- en toelatingsbeleide te bepaal en te ontwikkel, maar die Departement van Basiese Onderwys die finale sê te gee;
- Regulering van verskeie aspekte van Skoolbeheerliggame;
- Om graad R die nuwe verpligte skoolbegin-ouderdom te maak;
- Kriminaliseer ouers wat nie verseker dat hul kinders op skool is nie;
- Regulering van tuisonderwys;
- Bevestiging van die verbod op lyfstraf.
